## ● The First Edition of the Pan-African Project Management Conference 2017

### General objective

The general objective of the First Edition of the Pan-African PMC is to give a strong impetus to the awareness of the African community on the key role of project management technologies in the process of the Africa's economic transformation.

- 12) *Organization and institutional arrangements of regional, inter-regional and continental projects: Good practice and prospects in Africa;*
- 13) *Preparation and financial arrangements of projects: Good practice to promote in Africa;*
- 14) *Role of the owner: From identification and selection to project closure;*
- 15) *Governance of projects, programmes and portfolios: good practice and prospects in Africa;*
- 16) *Management of government projects in Africa: How to improve the absorptive capacity and the project delivery capability?*



## ● Venue of the Pan-African PMC 2017



The **Pan-African PMC** will be held at the Yaounde Conference Centre in Cameroon. Yaounde is the capital of Cameroon and is emerging as the Pan-African project management hub. Additional reasons for Yaounde, Cameroon include:

- (i) Its frequent description of “Africa in miniature” due to its diverse climate, geography, and cultures reflecting the diversity of Africa;
- (ii) It is one of the few African countries officially bilingual in English and French;
- (iii) It is through ANOR, (Standards and Quality Agency) one of the two (2) African countries that are participating members of the Technical Committee ISO/TC 258 on project, programme and portfolio management;
- (iv) it is the only African country to adopt since December 2014 as a national standard, the international standard ISO 21500: 2012 Guidance on Project Management;
- (v) there is already a PMI Chapter in Cameroon.

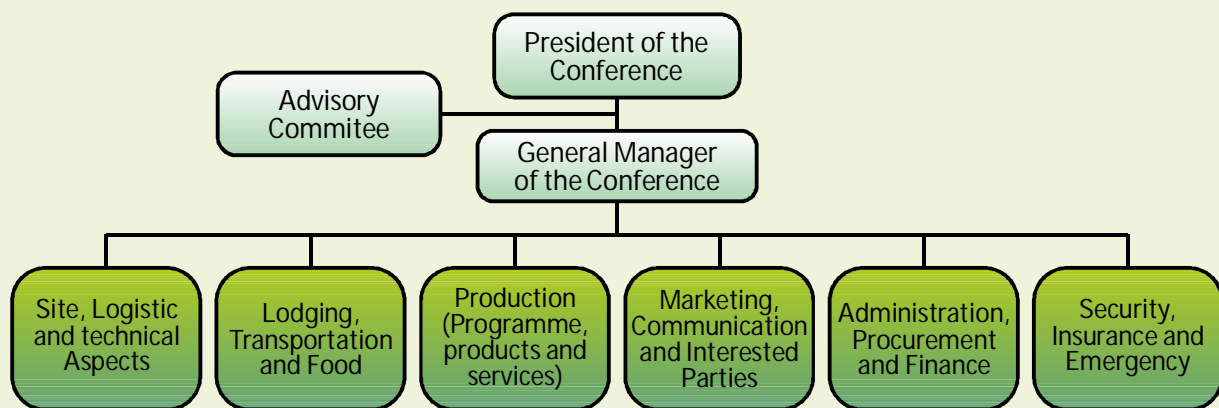




## ● Organizing Team of the Conference 2017
